Employer Classification Manual (ECM)

The Employer Classification Manual (ECM) houses descriptions of the classification categories used by the WSIB to classify the business activities of employers in Ontario. It describes the 800-plus Classification Units (CUs) used by the WSIB to classify all business activities into rate groups.
